## ENGLISH LEARNER PARENT INVOLVEMENT PLAN

### PART I. GENERAL EXPECTATIONS

Boardman Local Schools agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required school level parental involvement policies/plans meet the requirements of section 1118 of the ESEA, and each include, as a component, a school-parent compact consistent with section 1118(d) of the ESEA.

## **PART II. IMPLEMENTATION OF PARENTAL INVOLVEMENT POLICY**

3. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend.   - a. Facilitated by District Title I Coordinator.
4. Boardman Local Schools will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:
  - a. "Parent Notification" of placement in the EL Program.
  - b. Parents provided "English Learner Manual" upon entering program as well as annually.
5. Boardman Local Schools will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions in a timely Manner:
  - a. Instructor will honor all requests for parent-teacher meetings.
6. Boardman Local Schools will provide each parent an individual student report about the performance of their child on the State assessment in at least math and language arts:
  - a. Provided by O.D.E. and distributed by the district.
7. Boardman Local Schools will take the following actions to provide each parent timely notice: when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) :
  - a. Director of Instruction will provide notification to parents.
8. Boardman Local Schools will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --
  - the state's academic content standards,
  - the state's student academic achievement standards,
  - the state and local academic assessments including alternate assessments, the requirements of Part A,
  - how to monitor their child's progress, and
  - how to work with educators
9. Boardman Local Schools will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement:
  - a. Materials / Training will be provided in response to EI parents' requests
10. Boardman Local Schools will, with the assistance of its parents, educate its teachers, pupil services

personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools:

a. Where and when appropriate, qualified parents will be called upon to assist in PD.

11. Boardman Local Schools will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their Children:

a. This will be coordinated by the Director of Instructor.

12. Boardman Local Schools will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request:

a. All parents will be provided relevant documentation in their native language, if necessary.
